BOARD RESOLUTION – 2019 - 2

I. Adoption of The Cottonwood School's Principal's Annual Salary

WHEREAS, The Cottonwood School must adopt at a regular scheduled board meeting in open session the compensation of the highest compensated employee of the school.

NOWTHEREFORE BE IT RESOLVED, that the Board of Directors approve the annual salary for The Cottonwood School Principal in the amount of \$60,000. This amount constitutes 40% of the Principal's total compensation which is \$150,000 as they are the Principal of three schools.

I. Adoption of The Cottonwood School's Principal's Supplemental Benefits

WHEREAS, The Cottonwood School must adopt at a regular scheduled board meeting in open session the supplemental benefits of the highest compensated employee of the school, the Principal.

NOWTHEREFORE BE IT RESOLVED, that the Board of Directors approve the supplemental benefits/extra pay in the amount of \$233.33 a month, split equally among the three schools, and will include the following:
